

**SNODLAND CEMETERY**  
**TABLE OF FEES, PAYMENTS AND SUMS**

By the Town Council for the Town of Snodland, acting as the Burial Authority for the Town of Snodland fixed and settled from 1 April 2011

1.	<u>USE OF CHAPEL FOR SERVICES</u> (including music and flowers)	£75
2.	<u>INTERMENT FEES</u> (including all charges for Grave Digging etc) In graves for which no exclusive right of burial has been granted For any interment of the body of:	
	(a) Still Born – 1 month	Free
	(b) 1 month – 16 years	£50
	(c) Adult – Lawn Section	£450
	- Main Section	£550
	For any interment at a depth exceeding 5 feet, each additional foot in depth	£40
3.	For the interment of cremated remains in an existing grave	£125
4.	<u>EXCLUSIVE RIGHTS OF BURIAL</u> For the exclusive right of burial for <b>90 years</b> in an earthen grave For the exclusive right of burial for <b>90 years</b> for a child under 10 <b>(None-Snodland residents MUST purchase at time of burial)</b>	£450 £200

The Fees indicated include the Deed of Grant and all the expenses thereof

**A £100.00 surcharge will be levied against any funeral director who gives an incorrect size of coffin or grave measurement**

5. MONUMENTS, GRAVESTONES, TABLETS & MONUMENTAL INSCRIPTIONS

For the right to erect or place on a purchased grave for the period of 90 years:

- (a) A Headstone, Flat Stone or Footstone occupying a superficial area not exceeding 4 ft x 3 ft £100
- (b) KERBSTONES OR BORDERSTONES enclosing a space:-  
Not exceeding 7 ft x 3 ft £200
- (c) Any inscription after the first on a Gravestone, tablet or monument £50
- (d) A Vase
  - (i) with an inscription and not exceeding 12 inches in height £30
  - (ii) without an inscription £15

6. GARDEN OF REMEMBRANCE FOR CREMATED REMAINS

- (i) Purchase of a Kerbstone from Council not exceeding 3 ft in height...£500  
(this includes burial of ashes in the area)
- (ii) Initial purchase of a Rose Tree for 10 years £125
- (iii) Renewal of Rose Tree for a further 10 years £100

- 7. UPKEEP OF GRAVES – per annum £50

**The foregoing Fees, Payments and Sums will be doubled where the person to be interred or in respect of whom the right is granted is or was immediately before his death, not a Resident or Inhabitant of the Town of Snodland.**

The above fees, payment and sums, are hereby fixed and settled by Snodland Town Council.
