3.	Report and representation from Kent Police & Tonbridge and Malling Community Safety Team relating to anti-social behaviour in Snodland.
	DI Jones reported on the current situation in Snodland and what measures have been put in place to deal with anti-social behaviour. Additional police constables have been allocated to Snodland and Holborough lakes. They will provide a high visibility presence to deter criminality, hold offenders to account and to divert young people to positive and engaging schemes. Repeat offenders will be monitored and the necessary judicial options explored. It has become apparent that some of the youths are from outside of Snodland and additional resources have been requested to deal with these new findings. DI Jones advised that Snodland has been made a priority within the Tonbridge and Malling area. A multi-agency response is required to ensure that youths stop offending and the Police are working closely with TMBC and KCC. Mrs Finch from TMBC reported that they have successfully bid for youth support in Snodland, and this includes the commissioned services: The Ben Kinsella Trust, Salus and Olympia Boxing. KCC youth outreach workers will be operating twice a week at Holborough Lakes. Mrs Edmonds from the Community Warden Service advised that a permanent role for a community warden in Snodland had been secured and only been running for a year. Alongside that, KCC would like to promote working together with residents with the Community safety volunteer programme which would be working within the Community Safety team alongside community wardens being a visible presence within the community.
6.	Questions from the Public
	Pursuant to Standing Order 3 e & g Members of the public may make representation,

answer questions and give evidence at a meeting which they are entitled to attend in respect of the business on the agenda. A member of the public shall not speak for more than 3 minutes.

This Agenda item was moved to enable question and answer session with the police.

- Are the police patrols in the evening as well as during the day? There will be a
  mix of patrols that work from 7am to 10pm and others that work 24 hours a
  day. The police look at the data to see when the offending is happening the
  most and direct the teams to work at those times.
- The antisocial behaviour in the cricket meadow in the last few months where the youths are congregating around the table tennis table and are bombarding the gardens with beer bottle, cans, football and any type of missile they can get their hands on is becoming intolerable, what will be done about this? Not acceptable and again the police are going to address the problems with the increased presence.
- What does serious violence entail does that mean that a child can go up to someone and smack someone 5 times and make their nose bleed is that serious violence, and do you feel that a community resolution is sufficient? Cannot give an answer without the details being known and cannot discuss individual cases. Cannot make general sweeping statements about individual cases.
- How far can we go to protect ourselves? Law says you can use reasonable force to protect yourself.
- Some of these youths are 15–16-year-olds and have younger people with them and that's the worry that they are showing the younger ones bad habits. There should be things put in place to protect the young more vulnerable people? Schools Officers try to build and develop a relationship with these young people so that they can learn to trust us, and we can divert them away from the bad influences.
- Is there anything that you would attribute the increase in Anti-social behaviour to in general or is it a mixed picture? We are looking at children that do not have discipline, or they are very unhappy at home and have dysfunctional lives. Therefore, they go out on the streets. It is made worse by the economic situation as a lot of these kid do not have the funds to pay for summer holiday club. Therefore, they have nowhere else to go other than hang around with their friends. What we need to do is create situations where they can be with their friends but also with trusted professional adults that can show them a different way of behaving.
- The level of antisocial behaviour has increased significantly, along with the increase in thefts from local shops, large groups of intimidating youths congregating in the high street. It is believed that they are coming to the area for at least three reasons, one is because of the ease it seems to be from some shops in the area to acquire alcohol/cigarettes/vapes. And the other is lack of help from the police in helping with theft and the third is the lack of cctv in and around the high street and car park. What is being done about this?

TMBC will speak to trading standards about increased test purchasing on

alcohol. A bid has been put into TMBC for some mobile CCTV cameras and are just waiting to see if that funding has been agreed, and if it is then that will be live later in the year. This means that CCTV can be put up in problem areas. Existing CCTV in the Cricket Meadow will be repositioned to problem areas.

### 4. County Councillor's Report

Cllr Hohler (CC) reported on the following: -

- Reconnect is a Kent County Council led, community-based programme
  designed to get Kent's children and young people thriving following the
  pandemic. Clubs, businesses, and organisations have come together to create
  fabulous opportunities for children and young people. Together they can have
  fun, catch up on missed learning, engage in sports and activities, trips and
  experiences, receive mental health support, regain their confidence and gain
  access to career development opportunities.
- Has been pressing for a Community Support Warden in Snodland for some time and hope that this will be supported and that we can recruit.
- Police community club who are asking for funds to help 10-11 year olds understand about the difficulties of being online and on the internet and being led into bad behaviour by their peers. What they are doing is promoting discussions between children their peers, teachers and parents and the wider community to promote internet safety and a wider understanding of the dangers around at the moment. The CC went on to say that she had paid for books for each child aged 10-11 at St Katherines and Roberts Road School which can be taken home and shown to their parents. Teachers will also share the information at after school sessions and there is also a script for a play which they can do with the school.
- Childrens services had an Ofsted inspection in May and were given outstanding for three areas and excellent for one.
- Cuts to some existing subsidised bus services, including some school bus services.
- Reading challenge has started in the libraries, the challenge is to read 6 books during the summer holidays.
- Covid is on the rise, and we need to be vigilant
- Ukrainian refugees sponsors in place and the process is going quite quickly.

### Councillors raised the following points –

- Councils at all levels need to lobby government about the way bus services work, the County Council are reimbursed a pittance for free bus passes which is not acceptable, Rural services are being lost and developers are not always filling their obligations in 106 agreements.
- The cost of the bus passes is over £1000 for 2 children to attend school in Maidstone, many parents are now looking at using train services as they are cheaper and more reliable, which will have a knock-on effect on the bus services as they will continue to reduce their services.
